Mixture of :5-chloro-2-methyl-2H-isothiazol-3-one-and 2-methyl-2-isothiazol-3-one (3:1): The component identified by CAS# 55965-84-9 is a 3:1 mixture of 5-chloro-2-methyl-2H-isothiazol-3-one, CAS# 26172-55-4 and 2-methyl-2H-isothiazol-3-one, and 2-methyl-2H-isothiazol-3-one, CAS# 2682-20-4. The individual components are listed on the Australian Inventory of Industrial Chemicals AIIC}.

4. FIRST AID MEASURES

Inhalation: Move patient to fresh air, keep warm and at rest. Administer artificial respiration if patient stops breathing and seek immediate medical attention.

Skin Contact: Remove contaminated clothing including shoes and launder before reusing. Wash affected area with soap and water. Consult a doctor if irritation or rash develops.

Eye Contact: Flush eyes thoroughly with water for several minutes. Remove contact lenses after the initial 1-2 minutes and continue flushing for several additional minutes. If effects occur, consult a physician, preferably an ophthalmologist. Suitable emergency eye wash should be available in the work area.

Ingestion: Give 2 glasses of water to drink, if the patient is conscious. DO NOT INDUCE VOMITING. Seek immediate medical attention. Contact a doctor or poisons information center. If vomiting, place patient's face downwards and below hip level so that vomit does not enter the lungs.

Injection injury: Injection into the body when using airless spray equipment is a serious traumatic injury. IT IS IMPORTANT TO TREAT THE INJURY SURGICALLY AS SOON AS POSSIBLE. Do not delay treatment to research toxicity. The seriousness of the wound depends on exactly where the injury is located on the body. Whether the substance hit something on way in and deflected causing more damage and many more variables including skin micro flora residing in the paint or gun which are blasted into the wound. The injected paint contains acrylic latex which can result in rapid bacterial growth. For hand injection injuries doctors recommend immediate decompression of the closed vascular compartments of the hand to release the underlying tissue distended by the injected paint. Judicious wound debridement and immediate antibiotic treatment is necessary.

6. ACCIDENTAL RELEASE MEASURES

Small spills

Wear protective equipment to prevent skin and eye contamination. Avoid inhalation of vapours or dust. Wipe up with absorbent (clean rag or paper towels). .

Large spills

Shut off the source of the spill. Keep people away from spill area. Avoid inhalation. Slippery when spilt. Avoid accidents, clean up immediately. Use PPE when containing and clean up the spill.. Avoid accidents, clean up immediately. Wear protective equipment to prevent skin and eye contamination and the inhalation of vapours. Work up wind or increase ventilation. Contain - prevent run off into drains and waterways. Use absorbent (soil, sand or other inert materials). Collect and seal in properly labelled containers or drums for disposal. If contamination of crops, sewers or waterways has occurred advise local emergency services.
